OUR MISSION

Inspire exists to break the cycle of abuse and poverty through stable housing, education, training, and mentorship of foster and homeless youth.

OUR VISION

Our vision is to create a future where all youth continue to use the tools provided to make productive, self-sufficient and positive life choices.



VICTORIES FROM 2018

Inspire

Our Students

80% of our students consistently attended our Leadership Development Program (social-emotional training).

Overall, students attended school more consistently and dropped fewer classes than in 2017. Several youth experienced significant breakthroughs with their behavior + outlook and are showing tremendous growth.

Our Partners

11 new monthly partners were added in 2018. A new partnership with Stepping Stones for mental health classes and counseling has been very helpful for our Riverside Students.

Our Work

- Relocated our Riverside boys to a safer and larger home right across from RCC.
- Hired 4 enthusiastic and engaged Resident Advisors.
- Received funding to hire a new PT Case Manager.

OUR WORK

Inspire is a non-profit organization founded in 2005. Our goal is to create a safety net for former foster and homeless youth while they transition into productive adults. By providing educational opportunities we help them break the cycle of abuse and poverty. We aim to help every student earn a degree or vocational certificate and to learn valuable life skills to become self-sufficient.

Pillar One - Stability

We provide the opportunity to live independently with other roommates in safe and secure housing located near colleges and bus routes. Youth pay rent in the amount of \$100-250/per month plus 10% of their household utilities. Participants are expected to work together to maintain the home in a clean and organized manner and attend all house meetings and special events.

Pillar Two - Education and Employment

Participants are required to be enrolled in college or vocational school taking at least 9 units and working 15-25 hours a week. Inspire helps with:

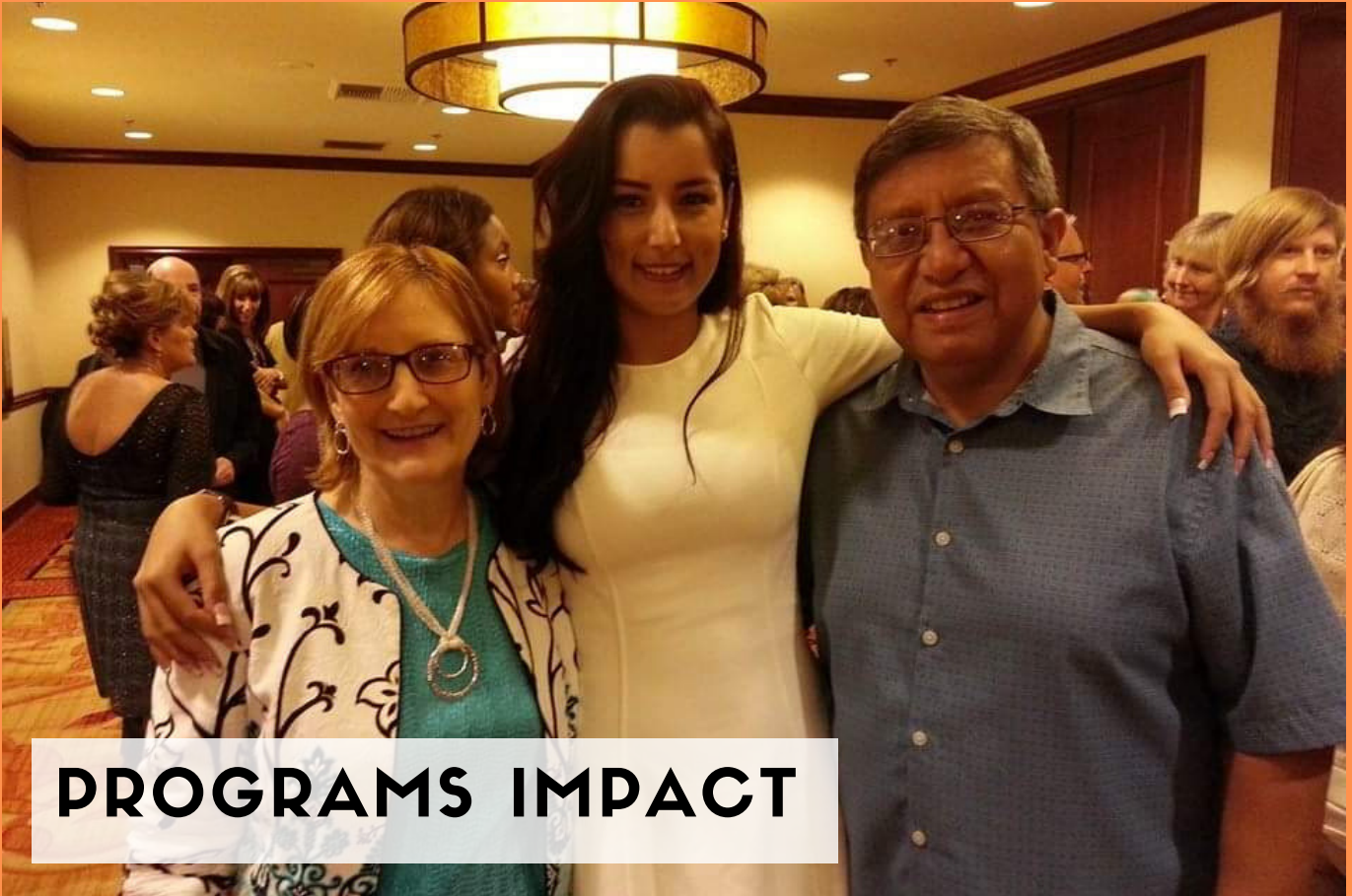
- Completing college applications
- Financial aid applications
- Career guidance
- Employment skills: Resume and Interview Skills

Pillar Three - Support Services and Life Skills

We believe that learning everyday activities are important to having a happy and successful life. Sometimes they have never been taught the basics. Twice a month we provide life skills training on some of the following topics:

- Cooking
- Nutrition
- Physical fitness
- Money management
- Basic car maintenance
- Interacting with peers
- Health education

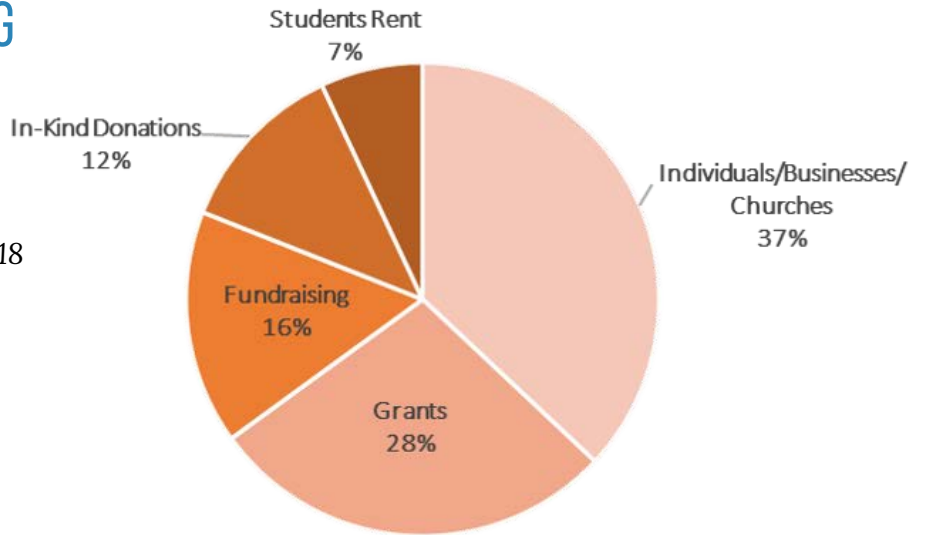
FINANCIALS

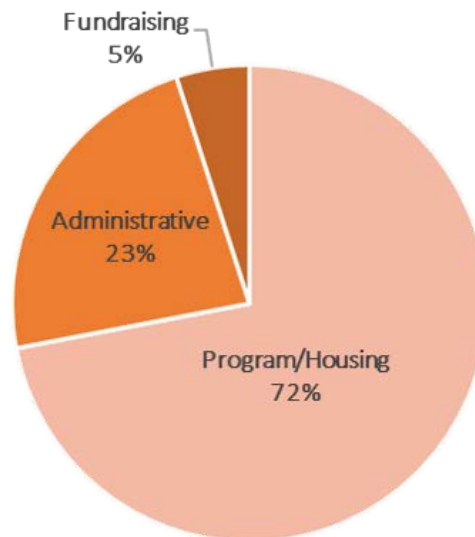
Total revenue under management 2018
